### MRIDANG-2025# Cultural Fest of MIT# March 22-23, 2025

MRIDNAG Annual Cultural Fest of MIT, Meerut is being conducted during March 22-23, 2025 (Saturday-Sunday).

In this respect, all the concerned are required to ensure compliance of following:-

1. Everyone must obey the Institute rules and must remain disciplined in entire campus. Students are required to co-operate Security/Faculty/Staff members in checking of bags/I-cards etc.
2. All must wear the valid identity card (own, issued by MIT). Without valid identity card (issued by MIT), no student shall be allowed to enter in the campus. Library Identity Card will not be acceptable. Lending of identity card is prohibited.
3. Consumption/possession/carrying-out of prohibited items (like Smoking/Drinking etc.) is strictly prohibited. Strict disciplinary action will be taken against defaulters.
4. Carrying-out of any type of liquid (water/any bottle/cold-drinks etc.) from the gate is strictly prohibited. In this respect, use institute's facilities.
5. Multiple-time entry/exit of any student will not be allowed.
6. Parking of vehicle (subject to owner's risk) is possible only outside the campus, which has limited capacity. Do not park vehicle on the road/in-front of the institute gate (do not obstruct the Road/Entry etc.)
7. Day scholars are not permitted either to enter or to stay in any of the hostels.
8. Only authorized students will be allowed to use institute's bus facility. Bus timings may alter that will be notified in due course of time. Inform these updated bus timings to your parents.
9. In case of any suspicious activity/person/emergency etc., inform immediately to Faculty/Proctorial Board/Security.
10. Stay away from poles/wiring etc. Ensure your safety first. Behave/act in a lawful manner.
11. Students, indulged directly or indirectly in any of the indiscipline act or found disobeying the institute rules etc., shall be debarred/suspended from the institute immediately and an inquiry committee will look-after the case after March 24, 2025 for its recommendation etc. During debarring/suspension period, concerned students shall not be permitted to enter in MIT campus/participate in any of the academic/curricular/extra-curricular/co-curricular activities.
12. All the stake holders must put their significant effort in successful conduct of MRIDANG-2025. The valuable contribution of all the stake holders will be appreciated.
